

## TITLE IV, PART A: STUDENT SUPPORT AND ACADEMIC ENRICHMENT PROGRAM

## Guidance on Allowable and Unallowable Expenditures

Below is a general overview of allowable and unallowable activities to support Title IV, Part A program planning activities.

A comprehensive needs assessment should be used to determine the appropriate use of funds as they relate to the three content areas. LEAs may apply for Title IV, Part A funds as a single applicant, as a member of a consortium, or as the lead member of a consortium.

LEAs and consortiums with allocations of \$30,000 and greater must use a <u>minimum</u> of 20% of their total allocation to support *Well-Rounded Educational Opportunities* AND a <u>minimum</u> of 20% of their total allocation to support *Safe and Healthy Students* content areas, AND use a portion to support *Effective Use of Technology*.
